**1. Introduction** Pursuant to Paragraph 9.04(f) of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, and Company's announcements dated 3 April 2023 (Reference No. GA1-17022023-00031) and 8 September 2025 (Reference No. GA1-08092025-00017). The Board of Directors wishes to announce that on 24 April 2025, North West Depoh Sdn. Bhd. ("**Defendant**") has served on the Company's wholly owned subsidiary, Swift Logistics Yard Sdn. Bhd. ("**Plaintiff**") with a Notice of Appeal against the decision of the Shah Alam High Court (High Court Case No. BA-22NCVC-427-10/2022) dated 16 April 2025 ("**Judgment**") and the appeal has been fixed for hearing on 5 February 2026.

Unless otherwise defined, all terms and abbreviations used in this announcement shall have the same meaning described in the previous announcements,

**2. Judgement** On 8 May 2025, the Defendant filed an application to stay the execution of the Judgment. On 12 August 2025, the Defendant obtained a partial stay of the execution of the Judgment, whereby the Court of Appeal only granted a stay on the delivery of vacant possession until 31 December 2025 and dismissed the stay of execution in respect of the monetary sums of RM20,438,977.90 as at 3 October 2025 with costs of RM10,000.00 and allocatur fees of RM400.00 in favour of the Plaintiff.

The Defendant has defaulted in settling the monetary component of the Judgment. Due to this default, the Plaintiff proceeded with enforcement actions.

The Plaintiff initiated garnishee proceeding on 26 September 2025 and writ of seizure and sale proceedings ("**WSS**") on 3 October 2025 (for immovable property) and 10 October 2025 (for movable properties) against the Defendant.

On 13 October 2025, the Plaintiff obtained a Prohibitory Order ("**PO**") against a piece of land owned by the Defendant located at Lot 104430 Off Jalan Sg Pinang 5/8, Taman Perindustrian Pulau Indah 2, 42920 Port Klang, Selangor.



On 15 October 2025, the Plaintiff served the Garnishee Show Cause Order to the Defendant's banks to satisfy the full judgement sums which remain due and owing. The execution for the WSS took place on 6 November 2025.

The details of the court proceedings taken by the Plaintiff to enforce the Judgment is tabled as follows:-
